Clerk-Treasurer-Clerk Howard asked Council about holding the last meeting of the year, it was decided to cancel that meeting and would call a special meeting if something came up. Clerk Howard addressed with Council old business from the November 12th meeting as Ms. Tuttle's comments and concerns about her bill. Clerk Howard mentioned that Ms. Tuttle had no right coming to the meeting and complaining about her adjustments on her bill. She was given the paperwork and signed an agreement with Deputy Clerk Waller that she agreed with the adjustment and would not dispute. Clerk Howard mentioned her disappointment in the Council allowing her to curse and slander the town over something that had been settled in a previous meeting. She was on the agenda to talk about a trash adjustment and not bring up an old bill. Clerk Howard also mentioned that Ms. Tuttle said she had done her research and that the Town has given back over eight thousand dollars in adjustments which is not correct for this error, those adjustments were over water leaks. Ms. Tuttle's error was in coding on her account that was placed more than 10 years ago before Deputy Clerk Waller even worked here and did not know this was done wrong. Once it was realized the problem was taken care of and reimbursement was given to her.
