The South Whitley Town Council and town employees met for the worksession on December 8, 2020 at 3:30 -4:00 p.m. in the Town Board Room. Present were Les Hoffman, Council President, Randy Cokl, Councilman, Brock Waterson Councilman, Kent Slater, Ron Anderson, Alex Sturgess, Mikel Vandevender, Jason Keim, Pam Waller, Pam Hoffman, Clerk-Treasurer and Annmarie Fetters.

Kent Slater reported Artistic Design is installing several lighted decorations throughout the town park, near the digital sign, across State Street and in the Pocket Park at no cost to the town. They will pick them up and store them the second week of January. The sewage plant is wrapping up the construction at the plant.

Ron Anderson reported the water tower disconnect cost \$12,000.00. There will be paperwork to sig and then the Town will control the tower's destiny. He contacted Triad regarding the remaining water project money, with \$617,000.00 left, approximately \$21,000 for their engineering services, leaving \$589,000 left. Plans will be drawn up for Sec A — Calhoun to Hillcrest, Section F Randolph to Mulberry, Calhoun to Jefferson, Section G Wayne to Main, Section J Alley along elementary, Poplar to Mulberry. State Road 14 Project may need to locate, may have to pay 10% of project, INDOT pay 90%. Tim Smith wants to be removed from the sidewalk 50/50 project.

Jason reported same amount of leaves collected this year as last year. He presented a quote for salt building from Noah Hilty. Salt machine should be ready to go for treating the wintery streets

.Alex Sturgess was asked by Council President to head up Parks and Mowing by taking on a Park Superintendent Role

.Pam Waller had no comment, Annmarie Fetters has been updating Town Website, but can't get on Electronic sign to add information.

Deputy Marshal Chuck Lewallen added that Tim Clark has stepped up covering 1st shift and school.

Retha Hicks presented a financial outlook report showing the status of our finances for future projects.

Board members discussed a 2% increase for employees for 2021, 2 bonuses to be given to full time employees, \$150.00 Christmas bonus and \$350.00 CoVID bonus for full time employees.

No further business, Council President, Les Hoffman, adjourned the meeting.

206 and 208 S STATE ST PROPERTY STATUS - Ryan Null is applying for an EDC loan, OLD BUSINESS work with another attorney for a Hold Harmless Agreement. Council President Les Hoffman asked

Attorney Hockemeyer if one or the other bidders would be interested in buying both buildings to hurry the sale along.

PUBLIC INPUT – John Phillips attended, asking why meeting minutes haven't been updated since March. Councilman Cokl had sent Jason Cline several months of meeting minutes and they have not been added to the Town Website. Clerk-Treasurer will contact Jason Cline about getting this caught up. We pay him \$100.00 per month to keep this updated if asked and also is our contact for email problems. John also said Social Media needs to be utilized as much as possible, suggesting Twitter, not Facebook especially.

PARK BOARD - No one attended DEPARTMENT HEADS:

TOWN MARSHAL – MIKEL VANDENDER – Chuck Lewallen Deputy Marshal filling in for Marshal Vandevender. Asking for approval to hire Tim Johnson a reserve office for Whitley Co for 20 years, good hire recommendation per Councilman Cokl. Asking starting wage of \$21.50, after 6 month .50 per hr increase. After attending academy wage increase to \$22.67. His start date 1st or 2nd week of January, 2021. Motion made by Councilman Waterson, seconded by Councilman Cokl, carried by vote of 3-0. Deputy Lewallen also asked about COVID paid leave, if additional 7 days were possible on top of 14 days. It was decided with a doctor's note to approve additional time as needed. Brock made motion to approve, motion died with no second.
