GENERAL WORKSESSION 5:30 PM

GENERAL WORKSESSION: The South Whitley Town Council met for the general worksession on December 14, 2021 at 5:30 p.m. in the Town Board Room. Present were Randy Cokl, President, Les Hoffman, Vice-President, Brock Waterson, Councilman, Mikel Vandevender, Town Marshal, Utilities and Pamela Hoffman, Clerk-Treasurer.

Tonya Porter of Star Insurance was on the agenda to discuss insurance renewal policies, but cancelled due to illness. The Board stated they were happy with Star insurance and didn't want to reach out for other insurance quotes.

The Board discussed Tony Starkey's offer of the Green Parrot Building and all three discussed the options before them of his newest offer of the Building on the contingency that the back of the Town's adjacent building be torn down. The Board agreed that they would accept the Green Parrot Building, but without any other conditions.

Town Marshal Vandevender asked for the Board to consider purchasing 5 tasers for the Police Department, as the tasers they have now have expired, and he can't get cartridges or batteries for them. He has had them for 13 years. There are 2 types available 1) Taser 7, which is wireless with a 4 year warranty at \$13,317.50 through Axum. 2) Taser XP26 with a 4 year warranty for \$9,307.85. He was leaning more to the Taser XP26 because the Taser 7 would have additional costs downloading information. Marshal Vandevender also said the department would also be needing 2 rifles @\$4,000.00 and handguns \$100.00. He suggested that the money they would have possibly used for the 2022 budget for a car grant be used to cover the tasers and equipment. He also said he would have a contract for Robert Lysaght for the Board to consider at the general meeting at 6:30p.m., as he has completed his training.

Board President Randy Cokl suggested the town have a Christmas Caroling on Sunday evening December 19th at 6:00 p.m. and take monetary donations for the town of Mayfield, Kentucky to help with their tornado relief. Randy will advertise on social media regarding this event. Money collected will be sent by check to Mayfield by Clerk-Treasurer Hoffman.

Clerk-Treasurer Hoffman informed of two new businesses in town, Time Square Café in the former Riverside Café building, to open for business the first of 2022, serving American, Mexican and Italian food. Also the South Whitley Car Wash was purchased by Clear Water Car Wash in Warsaw, Indiana.

No further discussion, the work session was closed at 6:18 p.m.
